Last year, working with several partner organizations, we developed and released a U.S. Policy Action Agenda on Climate, Health and Equity to establish principles for equitable and effective health-focused climate solutions. Currently endorsed by more than 150 physician, nursing and public health professional societies and academic institutions, and 500 hospitals, the Agenda provides ten key policy priorities to address climate change and promote the health of all Americans. ## **CALPIRG Students \*Winner**

Climate Leadership



Working on eight University of California campuses, CALPIRG Students ran and won a campaign for a UC-wide commitment to 100% renewable electricity. With 238,000 students across 10 campuses, UC's new plan to run completely on electricity from renewable energy by 2025 is the farthest-reaching with more higher ed campuses involved than any prior commitments in the nation. ## CivicSpark

Local Government Commission

CivicSpark, a program of the state Local Government Commission in partnership with the State of California, has accelerated climate action through two interactive paths: helping communities start and complete climate projects, and launching the next generation of climate leaders in cities and towns. CivicSpark was born out of the premise that climate leadership starts at the local level. See finalist video here.

## **Don Sampson**

Affiliated Tribes of Northwest Indians Climate Change Project

Since 2014, the Affiliate Tribes of Northwest Indians Climate Change Project has focused on building public and political support for climate solutions with its 57 Tribes. Don Sampson is known as a man who "gets it done", leading the effort to share ATNI's example with other tribes and First Nations throughout the U.S. and Canada in supporting their climate change efforts to undertake climate vulnerability assessments and develop adaptation plans. ### **Future Coalition**

Youth Climate Strike

Future Coalition — a network of youth-led organizations and youth organizers across the country — has been fostering community amongst young people making change and provides resources traditionally only available to adult-led organizing. Future Coalition coordinated the US Youth Climate Strike Coalition, the group of the nine leading national youth-led climate organizations that led the (Fridays for the Future) climate strikes in the US. ### **Green Teams**

Faith in Place Initiative

Faith in Place empowers Illinois people of all faiths to be leaders in caring for the Earth. Their key partners are Green Teams — three or more members of a house of worship who provide cooperative leadership to educate, connect, and advocate for environmental programs in churches and to build consciousness within their faith community's unique culture, context, and theological practices. They energize faith involvement in the Illinois environmental movement's annual Advocacy Day; since 2015, a total 1,463 people of faith, especially people of color, have participated. Green Teams were also crucial in educating and engaging state legislators to pass the Future Energy Jobs Act (FEJA) in 2016. See finalist video here.









## **Keep LA Cool**

Climate Resolve



Climate Resolve's Keep LA Cool initiative connects members of vulnerable and disadvantaged communities in Los Angeles with resources to help them keep cool in the face of more extreme heat days. It informs community members and community based organizations on how to advocate and participate effectively in civic processes; it advises policymakers and government agencies on climate-positive legislation and policies; and it convenes academic researchers, nonprofits and community-based organizations, and government actors to ensure varied viewpoints are heard. ## **Piper Christian**



Utah Concurrent Resolution on Environmental and Economic Stewardship After attending the COP21 UNFCCC Paris Climate Conference as a youth journalist, Piper returned to Utah and founded the Logan Environmental Action Force within her high school. Their first project was passing a resolution in statehouse, legislation resulting in action to address climate change. The group later introduced and led the statewide campaign for HCR 7. Piper was lead student organizer and the public spokesperson, allowing for success from start to finish of this remarkable advocacy campaign. See finalist video here.

## **Portland Clean Energy Fund Initiative**



Portland Clean Energy Fund is the first climate initiative in Oregon to be created and led by low-income people and people of color (frontline communities) and supported by a cross-sectional coalition to create green jobs, fund improvements to homes through renewable energy and energy efficiency investments, and support local businesses. The fund generates funding via a 1% surcharge on billion-dollar corporations. See finalist video here.

### Regeneración \*Runner Up





A place-based grassroots organization on the California coast, Regeneración works to protect farmworkers from climate change. Regeneración serves the primarily Mexican heritage farmworker community of the Pájaro Valley to help realize a shared vision of a just, thriving and resilient community by co-creating relevant and relatable climate solutions with the people most at risk of adverse effects. Regeneración engages leaders across a spectrum of health, social service, educational, and government agencies to explore how climate change is a threat to their successful mission delivery, catalyzes them to co-create and lead on solutions and follows the lead of local tribal bands. ### **Sunrise Movement**



Since launching in 2017, Sunrise Movement has grown from a handful of young adults to a movement that has helped mobilize hundreds of thousands of people to the streets and turned the Green New Deal from a fringe idea into the leading solution that meets the climate crisis at scale. This initiative garnered tremendous media attention in 2019 when activists staged sit-ins in lawmaker's offices on Capitol Hill. See finalist video here.
